

## SARDINE MARINE LIMITED WARRANTY

Each Sardine boat is covered by a combination of OEM (Original Equipment Manufacturer) and other warranties from other manufactures that includes most parts and accessories, such as engine, batteries, stereos, lights etc.

## **COVERAGE PERIODS:**

- **Ten-years (10)** Hull and deck structure. Structural elements include fiberglass, fiberglass-reinforced stringers, matrix grid systems and bulkheads.
- Two (2) years Gel coat finish, and protection against osmotic blistering
- Two (2) years Canvas products manufactured by **SARDINE MARINE** (e.g., Bimini top).
- Two (2) years Upholstery items manufactured by SARDINE MARINE.
- One (1) year Materials and workmanship, including most materials, and components used in the boat's construction.
- One (1) year Painted graphics or decals and clear coat finishes.
- One-to Three (1-to-3) year Equipment and accessories NOT manufactured by SARDINE MARINE; (e.g., outboards, navigational and courtesy lights, bilge pump, stereo and its components) shall be covered by the respective original equipment manufacturers' warranties periods generally are from one (1) to three (3) years. Any warranty claim must be directed to the respective manufacturer

## **LIMITATIONS AND EXCLUSIONS:**

**REGISTRATION:** To activate your warranty, the owner is required to fill a Warranty Registration Form at our office or at <a href="https://www.sardinemarine.com">www.sardinemarine.com</a> not later than 90 days from purchasing date.

**COVERAGE TERRITORY**: This Limited Warranty is limited to Failures which occur, and repairs that are made, within the territorial waters of the United States of America and Canada.

**TRANSFER RIGHTS**: This Limited Warranty is for the benefit of the original purchaser only.

**LIMIT OF LIABILITY:** Our liability for the Craft shall not exceed the total amount paid for the boat and there is a deduction of 20% per year of use from the purchasing date

**NO VERBAL WAIVER OR MODIFICATION:** This Limited Warranty sets forth the entire agreement between Manufacturer and original Owner for repair and reimbursement of the covered parts. We do not authorize any party to make any revisions, modification and/or wavier of these terms. There are no oral modifications, waiver or extensions.

MARINE recommendations as outlined in the owner's manual. You are responsible of the proper use of compatible cleaning products on your boat's parts and its components. The electric accessories are protected by fuses. It is owner's responsibility to use same indicated fuse rating and follow battery polarity to avoid electric shorts and consequent possible fires.

**VENUE AND JURISDICTION:** Any litigation related to this limited warranty must be maintained in either the federal district court for the Southern district of State of Florida, (or any successor jurisdiction) or in a state court sitting in Dade County, Florida. You hereby irrevocably consent and submit to the exclusive jurisdiction of the applicable federal or state courts specified herein and irrevocably waive any objection you may have based upon improper venue, forum non conveniens, or other similar doctrines or rules.

**LIMITATION OF ACTIONS:** Any action, at law or equity, must be commenced by filing within one year of the date of the first claim made on a particular component.
